I want to thank everyone for all of your efforts over the last few weeks. Because of your efforts, HB 71 was tabled today by its author, Chairman Richard Smith. We want to thank Chairman Smith for listening to all the calls and reading all the emails and deciding to table the bill. Because of the bill being tabled, this means HB 71 is no longer viable for this legislative session.

Going forward, SB 8 will be the bill that we will be working on to solve the Surprise Insurance Coverage. While the bill is far from perfect, we believe we can work on this issue to protect patients and be fair to physicians.

As we prepare for the remaining twelve (12) days of the legislative session, please take a moment and thank all the members of the House of Representatives for their opposition on HB 71. These members really stood up for physicians and patients these last few weeks. They really need to hear from you.
