1 **Executive Summary**

2 Like MAG’s House of Delegates, the American Medical Association House of Delegates
3 meetings represent the pinnacle of representative democracy, with passionate debate on a
4 multitude of critical issues in a *collegial* fashion—unlike too many of our state and national
5 legislative bodies. The AMA HOD—proportionately comprised [one for every 1,000 AMA
6 members of each] of over 650 delegates from every state and a host of national medical specialty
7 societies, as well as special sections--convenes in two meetings each year. Its annual meeting is
8 held in Chicago every June and in November, its interim meeting is held in various (warmer)
9 locations around the country.

10
11 In 2019, the MAG HOD sent 5 delegates and 5 alternates to the AMA House, based on total
12 AMA membership of all physicians in GA, not just MAG members who are also AMA
13 members. When total AMA membership increases in GA, we elect additional delegates and
14 alternates. Thanks in no small part to the outstanding activities of GA physician leaders
15 (especially AMA President Patrice Harris and AMA Trustee Sandra Fryhofer), Georgia gained
16 enough extra AMA members to seat an additional delegate and alternate at the 2020 AMA
17 annual meeting in June. Georgia is also represented at the young physician section meeting,
18 residents & fellows physician section, and medical student section. There are other sections that
19 welcome Georgia representatives. This includes the Organized Medical Staff Section (recently
20 revitalized in GA) and the International Medical Graduates Section, among others.

21
22 To amplify the influence of our relatively small delegation, the GA Delegation helped form the
23 Southeastern Delegation (SED) to the AMA over 30 years ago--which brings 120 delegates to
24 the proceedings—and which I had the honor to Chair from 2017 – 2019. In addition, there are
25 other Georgia physician leaders who attend AMA meetings as representatives of their national
26 specialty societies. Those who are MAG members (most, but not yet all, dang it) have agreed to
27 join in GA Delegation activities as much as they can, and their input and advocacy is critical to
28 our success.

29
30 Over the course of these two grueling meetings, hundreds of resolutions and reports are
31 proposed, deliberated, and voted upon. But the Georgia Delegation works all year to accomplish
32 the policies and initiatives of MAG.

33
34 The challenges of hosting a physical meeting due to Covid-19 resulted in last June’s annual
35 meeting evolving into a 2-hour virtual meeting at which almost no policy was debated, although

1 we had resolutions from the 2019 MAG HOD ready for debate. The interim meeting in
2 November will also be a virtual meeting at which policy *will* be debated.

3
4 What follows is an extensive summary and analysis of the disposition of MAG resolutions at the
5 national level over the past year. We hope you will agree this report reflects very favorably on
6 the directives of the MAG House of Medicine and the diligence of the Georgia Delegation.
7 Attached, as well, is the Delegation Service Record that details the specific activities of each
8 delegation member at his/her assigned responsibilities.

9
10 This report concludes with a recommendation that the MAG HOD approve the actions of the
11 MAG AMA Delegation.

12
13 AMA INTERIM MEETING -- November 16-19, 2019

14
15 The meeting was held at the Manchester Grand Hyatt in San Diego. MAG CEO Donald Palmisano and
16 Director of Corporate Relations Ryan Larosa staffed the meeting. The Delegation arrived in San Diego
17 on Friday, November 15 and attended the OSMAP Meeting that was scheduled at 2:00 p.m. OSMAP is
18 composed of state medical association presidents, past presidents, and presidents-elect. Attendees were
19 given an update from the Litigation Center, an update on current AMA issues, priorities and activities,
20 and an update from the Physicians Foundation. Those attending also heard from AMA and others on
21 surprise billing and what is happening in Washington to resolve the issue in favor of patients and
22 physicians.

23
24 The MAG House of Delegates sent several resolutions to the AMA for consideration, which were
25 assigned to various reference committees for a hearing and recommendation to the AMA HOD. A
26 summary on each resolution submitted to the AMA HOD is recorded below:

27
28 Resolution 105A.19 Resolves 1& 2
29 Follow-up on Abnormal ~~Radiology~~ Radiology Test Findings (New Title)
30 MAG Resolution 105A.19 Resolves 1& 2

31 Follow-up on Abnormal Radiology Findings

32 Adopted as amended Resolve 1, that the Medical Association of Georgia (MAG) delegation to
33 the American Medical Association (AMA) present a resolution that the AMA supports the
34 adoption of evidence-based guidelines on the process for communication and follow up of
35 abnormal test findings to promote better patient outcomes.

36 Adopted as amended Resolve 2, that the AMA work with appropriate state and specialty medical
37 societies to enhance opportunities for continuing education regarding professional guidelines and
38 other clinical resources to enhance the process for communication and follow up of abnormal test
39 findings to promote better patient outcomes.

40 AMA Resolution 309

41 RESOLVED, that our American Medical Association advocate for the adoption of evidence-
42 based guidelines on the process for communication and follow-up of abnormal medical test
43 findings to promote better patient outcomes, and

44 RESOLVED, that our AMA work with appropriate state and specialty medical societies to
45 enhance opportunities for continuing education regarding professional guidelines and other
46 clinical resources to enhance the process for communication and follow-up of abnormal medical
47 test findings to promote better patient outcomes.

48 Final Action: Referred

49 Due to complexity of the resolution Reference Committee C recommended referral and the AMA
50 HOD agreed. *The Delegation considers this a positive outcome, as the issue is still in play.*

1 MAG Resolution 108A.19 Resolve 2

2 Definition of New Patient

3 Adopted as amended Resolve 2, that the MAG delegation to the American Medical Association
4 (AMA) present a resolution asking for the AMA to advocate for the definition of a “new patient”
5 to represent the multitude of factors and time needed to appropriately evaluate a patient’s health
6 condition and in accordance with relevant payer guidelines.

7 AMA Resolution 816

8 RESOLVED, that our American Medical Association advocate for the definition of a “new
9 patient” to represent the multitude of factors and time needed to appropriately evaluate a patient’s
10 health condition and in accordance with relevant payer guidelines.

11 Final action: Policies H-70.919 and H-70.921 be reaffirmed in lieu of Resolution 816.

12
13 Substantial testimony supported reaffirmation of existing AMA policy regarding the CPT
14 Editorial Panel process in lieu of Resolution 816. The Chairman of the CPT Editorial Panel spoke to the
15 independent nature of the CPT editorial process and the recent work of the panel on office visits. While
16 limited testimony called for referral for decision, other speakers emphasized that the proper forum for
17 discussing the concerns raised in Resolution 816 is the CPT Editorial Panel. Below are the two AMA
18 policies that were reaffirmed:

19 Policy H-70.919

20 Our AMA reinforces that the CPT Editorial Panel is the proper forum for addressing CPT code
21 set maintenance issues and all interested stakeholders should avail themselves of the well-
22 established and documented CPT Editorial Panel process for the development of new and revised
23 CPT codes, descriptors, guidelines, parenthetical statements and modifiers.

24 Policy H-70.921

25 Our AMA policy is that future efforts to substantially revise Evaluation and Management (E&M)
26 codes should only occur under the auspices of the CPT Editorial Panel and then through a broadly
27 inclusive process that provides for significant and meaningful input from state medical
28 associations, medical specialty societies and public and private payers.

29 *The Delegation considers this to be a neutral outcome.*

30
31 MAG Resolution 111A.19 Resolve 2

32 Medication Production Transparency

33 Adopted as amended Resolve 2, that the MAG delegation to the American Medical Association
34 (AMA) present a resolution asking for the AMA to encourage Congress to support national
35 legislation to make it a requirement that the identity of the manufacturer and the country of origin
36 be included on the label of the bottle given to a patient.

37 AMA Resolution 930

38 Origin of Prescription Medication Production Transparency

39 RESOLVED, that our American Medical Association advocate to Congress to support national
40 legislation to make it a requirement that the identity of the manufacturer(s) and the country
41 (countries) of origin of the components of prescription medications be included on the label of the
42 container dispensed to a patient, including generic medications.

43 AMA Resolution 930 was combined with Resolution 932 which reads:

44 RESOLVED, that our American Medical Association (AMA) support studies that identify the
45 extent to which the United States is dependent on foreign supplied pharmaceuticals and chemical
46 substrates (New HOD Policy); and be it further

47
48 RESOLVED, that our AMA support legislative and regulatory initiatives that help to ensure
49 proper domestic capacity, production and quality of pharmaceutical and chemical substrates as a
50 matter of public well-being and national security (New HOD Policy); and be it further

1 RESOLVED, that our AMA encourage the development and enforcement of standards that make
2 the sources of pharmaceuticals and their chemical substrates used in the United States of America
3 transparent to prescribers and the general public. (New HOD Policy)

4 Final Action: Resolution 932 was adopted in lieu of Resolution 930

5 Reference Committee K heard testimony largely in support of the intent of these resolutions.
6 Significant testimony also noted frustration with transparency related to the drug supply chain. Many
7 commenters noted their support for the language in Resolution 932 and noted the urgency associated with
8 the problem. It was also stated that legislation is currently being deliberated related to the issues in
9 Resolution 932 and the adoption of this policy should empower the AMA to be engaged in the
10 deliberation. Therefore, Reference Committee K recommended that Resolution 932 be adopted in lieu of
11 Resolution 930 and the House agreed. *Considering that testimony revealed that multiple components of*
12 *single medications may be derived from different countries, the Delegation considers this a neutral*
13 *outcome.*

14
15 MAG Resolution 303C.19 Resolve 4

16 Vaping Ban for under 21 and Additional Resolutions

17 Adopted Resolve 4, that the MAG Delegation to the American Medical Association (AMA)
18 present a resolution to reaffirm AMA policy on tobacco sales and flavoring and make the above
19 stated policies universal in all states in the union.

20 AMA Resolution 931

21 RESOLVED, that our American Medical Association reaffirm policy on tobacco sales and
22 flavoring and renew efforts to advocate to make these policies universal in all the states in the
23 Union.

24 Final Action: Current Policies H-495.984 and H-495.971 were reaffirmed. Resolution 931 was placed on
25 the reaffirmation consent calendar and considered on Sunday, November 17, 2019. (Current policy is
26 attached to this report). *The Delegation considers this to be a neutral outcome.*

27
28 MAG Resolution 315C.19, Resolves 5-6

29 Patients Right to Know

30 Adopted Resolve 5, that the MAG delegation to the American Medical Association (AMA)
31 submit a resolution that the AMA provide educational resources, both printed and online video,
32 which health care systems could provide to patients and which consumers could access directly.
33 Adopted Resolved 6, that the MAG delegation to the AMA submit a resolution that the AMA
34 advocate for increased resources for federal and state programs like GeorgiaCares and educate
35 physicians, hospitals, and patients about the availability of these programs.

36
37 AMA Resolution 817 – Transparency of Costs to Patients for Their Prescription Medications Under
38 Medicare Part D and Medicare Advantage Plans

39 RESOLVED, that our American Medical Association advocate for transparent patient educational
40 resources on their personal costs for their medications under Medicare Part D and Medicare
41 Advantage plans—both printed and online video—which health care system could provide to
42 patients and which consumers could access directly.

43 RESOLVED, that our AMA advocate for increased resources for federal and state programs like
44 GeorgiaCares and educate physicians, hospitals and patients about the availability of these
45 programs.

46 Final Action: Resolution 817 was adopted as amended:

47 RESOLVED, that our American Medical Association advocate for transparent patient educational
48 resources on their personal costs for their medications under Medicare ~~Part D~~ and Medicare
49 Advantage plans—both printed and online video—which health care systems could provide to
50 patients and which consumers could access directly (Directive to take action); and be it further

1 RESOLVED, that our AMA ~~advocate for support~~ increased ~~resources~~ funding for federal and
2 state health insurance assistance programs like ~~GeorgiaCares~~ and educate physicians, hospitals
3 and patients about the availability of these programs. (Directive to Take Action). *This is a*
4 *positive outcome for our MAG position.*

5
6 UPDATE ON PREVIOUS GEORGIA RESOLUTIONS

7
8 Board of Trustees 12-I-19

9 Distracted Driver Education and Advocacy

10 Status of Implementation: Enterprise Communications will amplify the efforts of Advocacy,
11 Health and Science, and JAMA through appropriate media channels and will work with Physician
12 Engagement to amplify via AMA owned channels such as social media, AMA Wire, etc. Enterprise
13 Communication will evaluate opportunities to support current and future advertising campaigns on
14 distracted driving to highlight the risks to the public. *This is a positive outcome for our initiative.*

15
16 CCB Report 3-I-19

17 AMA Delegation Apportionment

18 The Council on Constitution and Bylaws recommended the following and the HOD adopted the following
19 amendments:

20 1. That the following amendment to the AMA Bylaws be adopted.

21 2.1 Constituent Associations. Each recognized constituent association granted
22 representation in the House of Delegates is entitled to delegate representation based on
23 the number of seats allocated to it by apportionment, and such additional delegate seats
24 as may be provided under Bylaw 2.1.1.2. Only one constituent association from each U.S. state,
25 commonwealth, territory, or possession shall be granted representation in the
26 House of Delegates.

27
28 2.1.1 Apportionment. The apportionment of delegates from each constituent association is one
29 delegate for each 1,000, or fraction thereof, active constituent and active direct members of the
30 AMA within the jurisdiction of each constituent association, as recorded by the AMA as of
31 December 31 of each year.

32 2.1.1.1 The December 31 count will include pending members for purposes of
33 apportionment; however, pending members shall not be recounted the following year
34 absent membership renewal. This Bylaw will sunset as of the close of business of the
35 2022 Interim Meeting unless the House of Delegates acts to retain it.

36 [Subsequent bylaw provisions shall be renumbered] (Modify Bylaws)

37
38 2. That Policy G-600.016(2) be amended by addition to read as follows:

39 “Pending members” (defined as individuals who at the time they apply for membership
40 are not current in their dues and who pay dues for the following calendar year) will be
41 added to the number of active AMA members in the December 31 count for the purposes of
42 AMA delegate allocations to state medical societies for the following year and this total will be
43 used to determine the number of national medical specialty delegates to maintain parity. (Modify
44 Current HOD Policy). *This is a very positive outcome for our position and resulted in an*
45 *additional MAG delegate and alternate to the AMA HOD for 2020!*

46
47 The AMA Interim 2019 Meeting adjourned with no inkling of the coming pandemic that was poised to
48 impact the practice of medicine and our population so significantly in 2020.

AMA ANNUAL MEETING -- June 7, 2020

1
2
3 In February, MAG was informed that Georgia's AMA membership had increased by enough members to
4 seat an additional delegate and alternate in 2020. The Delegation agreed that, until the MAG HOD could
5 meet again, Senior Alternate Delegate Jack Chapman would serve in the new delegate position and MAG
6 President Andrew Reisman would serve as alternate delegate at A-20.

7
8 By March of 2020, our planet was negatively impacted by the novel coronavirus Covid-19. With the
9 wide spread of the virus, almost all travel was suspended, and many societies suspended their face-to-face
10 meetings opting to hold virtual meetings. The AMA was no exception and suspended its annual meeting,
11 opting for a limited online approach because it was neither safe nor wise for that many physicians to leave
12 their positions as first responders and gather for a meeting.

13
14 On April 25, 2020, the AMA speakers sent an official call to delegates and alternate delegates of a special
15 virtual meeting of the House of Delegates. All were informed that the purpose of the meeting as defined
16 by the request of the AMA Board of Trustees, which was to inaugurate the new president, to elect officers
17 and council members, and to conduct only essential business that would be required for AMA. The
18 process of elections required the Southeastern Delegation to acquire the skills to conduct virtual
19 interviews of candidates for office. This was achieved using the Zoom platform.

20
21 On May 27, 2020 HOD members received notice that voting credentials and reports were posted on-line
22 for comments. Speakers reported that the meeting would contain a narrow focus. Reports were limited to
23 contain only a few items of business. The AMA HOD convened on Sunday, June 7. Elections were held
24 and Reference Committee F and amendments to the Constitution and Bylaws were considered. AMA
25 members voted to elect Gerald Harmon (SC), president-elect, re-elected Willarda Edwards (SED) and
26 elected Ilse Levin (SED) to the BOT. Susan Bailey (TX) was installed as AMA president. Outgoing
27 President Patrice Harris (MAG) gave a stirring address.

28
29 Reference Committee F and Amendments to the Constitution and Bylaws were the only reference
30 committees considered, to comply with AMA procedural mandates. No policy resolutions were submitted
31 for consideration. Final action on this reference committee is located on the AMA Web site and can be

AMA INTERIM MEETING—November 13-17, 2020

37 The AMA 2020 Interim meeting will again hold a virtual meeting, but policy issues will be debated in
38 virtual reference committees in advance. The AMA Chair and Speaker have requested that all AMA
39 components prioritize issues to be considered virtually at this time.

40
41 We should take this recommendation to heart as we debate issues to go to the AMA at our upcoming
42 2020 MAG Virtual Annual HOD Meeting.

43
44 At the 2019 MAG HOD, several resolutions were adopted to be submitted to the AMA HOD but were
45 deferred. It is your Delegation's intention to introduce each of the remaining resolutions to the AMA I-20
46 meeting. The following is a list of the MAG resolutions that we intend to present. It is possible that some
47 will not be considered urgent by the new AMA Resolutions Committee.

48
49 102A.19 -- Reinstate Consultation Codes for Medicare, United Health Care, and Cigna
50 Adopted Resolve 1, that the Medical Association of Georgia (MAG) delegation to the American Medical
51 Association (AMA) present a resolution that AMA proactively engage and advocate with any commercial

1 insurance company that discontinues payment for consultation codes or that is proposing to or
2 considering eliminating payment for such codes, requesting that the company reconsider the policy
3 change.

4
5 106A.19 -- Medicare Advantage Record Requests

6 Adopted Original Resolution, that the Medical Association of Georgia delegation to the American
7 Medical Association (AMA) provide a resolution to the AMA to work with the relevant agencies and
8 stakeholders to prevent Medicare Advantage plans from requesting records from practices solely to data
9 mine for more funds and limit requests to 2% of plan participants, otherwise the plan will reimburse the
10 practices for their efforts in obtaining the requested information.

11
12 116A.19 -- Surveillance Management System for Organized Medicine Policies and Reports

13 Adopted Resolve 1, that the Medical Association of Georgia (MAG) delegation to the American
14 Medical Association (AMA) present a resolution asking the AMA to develop a prioritization matrix
15 across both global and reference committee specific areas of interest.

16 Adopted Resolve 2, that MAG requests the AMA to develop a web-based surveillance
17 management system, with pre-defined primary and/or secondary metrics, for resolutions and reports
18 passed by their respective governance body.

19 Adopted Resolve 3, that MAG requests the AMA share previously approved metrics and results
20 from the surveillance management system at intervals deemed most appropriate to the state and local
21 membership of organized medicine, including where and when appropriate to their patients.

22
23 305C.19 -- Strengthening the Accountability of Health Care Reviewers

24 Adopted Resolve 2, that the MAG delegation to the American Medical Association (AMA)
25 present a resolution that AMA advocate for legislation to require physicians contracted by health insurers
26 or pharmacy benefit managers to possess an active license in the states where they review prior
27 authorizations and be subject to the rules, statutes, medical board, and peer review of the state in which
28 the prior authorization request is made.

29 Adopted Resolve 3, that the MAG delegation to the AMA present a resolution that the AMA
30 advocate for the repeal of the Employee Retirement Income Security Act (ERISA) as it pertains to prior
31 authorization decisions.

32
33 CONCLUSION AND RECOMMENDATION

34
35 It is such an honor to serve as Chairman of the AMA Georgia Delegation and I am really proud
36 of all our elected delegates and alternate delegates including Vice-Chair Sandra B. Reed, M.D.,
37 Michael E. Greene, M.D., John S. Antalis, M.D., Billie Luke Jackson, M.D., Jack M. Chapman,
38 Jr., M.D., C. Gary Richter, M.D., John A. Goldman, M.D., Ali Rahimi, M.D., and Charles I.
39 Wilmer, M.D., as well as all the other MAG Section and other National Specialty Delegates and
40 Alternates who are MAG members. In addition, the Delegation extends our appreciation to MAG
41 Executive Director Donald Palmisano, Director of Corporate Relations Ryan Larosa and Executive
42 Secretary Donna Glass who are essential to the activities and successes of the Delegation.

43
44 In order for MAG to continue to have 6 delegates and alternates to AMA HOD activities, it is critical for
45 each of you to renew your AMA membership and to advocate for it widely to your colleagues. Truly the
46 AMA is representing the physicians' perspective admirably at the national level!

47
48 In accordance with MAG Policy, we have attached our Delegation Service Record to provide
49 you our record of attendance at the many events and activities.

1 All of us on the GA Delegation look forward to serving you at the upcoming AMA 2020 Interim
2 and 2021 Annual HOD Meetings. Please don't hesitate to contact any us should you have

4 AMA House of Delegates in November 2020.
